TREASURER:

Sue D'Aloia: Financials were sent out.

RIFLE/PISTOL:

Bob Tollman: The ammo shortage is killing us. People that usually stay 4 hours stay 40 minutes. We added 34 new membership. Attendance is way down. We will be closed on Fridays except for the RO's in the morning.

AIRGUN:

Alex Modic: We have moved outdoors. We had a work crew that removed the fallen tree and fixed the canopy temporarily. It will be good enough to last the season. Things are going good. We still could use some dirt to reinforce the berms. Eagle Excavating may be looking to dump some dirt. The skidsteer seems to be leaking. We are looking for a volunteer to handle the maintenance on mowers and equipment etc.

SOP for handling range deposits needs to be addressed.

ARCHERY:

Don Walker: We're doing good on targets. Biz is really slow.

SHOTGUN:

Bill Lerch: April was a strong month. Sales were up 27% over our best April in 5 years. We're making progress on profitability. The Falcons are helping with a strong start and the 5 stand providing extra sales. We are being impacted by the ammo shortage. Time will tell how this will affect the summer. Recob cannot promise regular orders but will try to accommodate us. We have enough ammo for about a couple months. Sales are up depending on availability.

Shooters that can't find ammo or those that normally reload are buying shells. The Falcons are a big portion of our business. They are shooting 2 nights a week as well as 5 stand. They have sufficient ammo.

The cashier is checking all ammo so nonmembers do not have to buy ammo. That's helping ease the shortage. RO's can watch the field instead of having to check shells. We gained 1 RSO. We have a full roster for the summer. We are still looking for a puller and a cashier.

The lead reclamation company took samples today. They will give us a report whether we should do it this year or next. We should know around the end of the week.

Black Powder: Dan Christiansen: Things are really slow. We are refinishing the tables and benches.

COWBOY:

George Broecker: We hosted a match this past weekend. It was a great weekend. We had 31 shooters which was good, especially for Mother's Day weekend.

Two scout troops are signed up to shoot on May 15th at the 22 range. George has given them permission to use the Cowboy range that weekend. Scott Jackson will be in charge.

CORRESPONDENCE:

We will work on a standard procedure for all ranges to make bank deposits. This should make things easier for the accountant.
